#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Public Safety - Missouri Highway Patrol**, and the **Department of Corrections** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Office of Prosecution Services (OPS)** assume the proposal would not have a measurable fiscal impact on their agency. The creation of a new crime creates additional responsibilities for county prosecutors which may, in turn, result in additional costs which are difficult to determine.

For the purpose of this proposed legislation, officials from the **Office of State Public Defender** (**SPD**) cannot assume that existing staff will provide effective representation for any new cases arising where indigent persons are charged with the proposed new crime of trespass on a nuclear power plant - a new class E felony.

While the number of new cases (or cases with increased penalties) may be too few or uncertain to request additional funding for this specific bill, the SPD will continue to request sufficient appropriations to provide effective representation in all cases where the right to counsel attaches.

**Oversight** assumes the SPD can absorb the additional caseload that may result from this proposal.

Officials from the **Office of the State Courts Administrator** state there may be some impact, but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.

In response to a previous version, officials from **Callaway County** assumed the proposal would not fiscally impact their agency

Officials from the Callaway County Sheriff's Office did not respond to **Oversight's** request for fiscal impact.

**Oversight** assumes this proposal will not have a fiscal impact.
