#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the **Department of Elementary and Secondary Education** assume the proposal will have no fiscal impact on their organization.

Officials from the **Department of Health and Senior Services** assume the proposal will have no fiscal impact on their organization.

Officials from the **Summersville R2 School District** assume little to no fiscal impact.

In response to a previous version, HB 2129 (LR 5376-01), officials from the **Wellsville-Middletown R-1 School District** assumed a potential negative fiscal impact depending on the cost of the specified curriculum and staff training.

Officials from the **Kirksville R-III School District** assume the proposal will have no fiscal impact on their organization.

In response to a previous version, HB 2129 (LR 5376-01), officials from the **Northeast Nodaway R-5 School District** and **West Plains School District** assumed the proposal would have no fiscal impact on their organizations.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current appropriation.

**Oversight** will show a fiscal impact of \$0 (districts can absorb costs with existing resources) to an unknown cost for materials and staff time.

#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This bill requires that beginning in school year 2019-20 students in public or charter high schools shall receive 30 minutes of instruction providing information on decisions about organ, eye, and tissue donation before graduation. Schools shall include the instruction in any existing curriculum for a subject selected by the school. Instruction shall be based on a program established by Gift of Life, Inc, or a nationally recognized program that provides unbiased information on organ, eye, and tissue donation.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
