FISCAL ANALYSIS

ASSUMPTION

Officials from the Department of Revenue, the Department of Transportation, the Department of Public Safety - Missouri Highway Patrol, the Department of Public Safety - Office of the Director, the Department of Corrections, and the Office of Prosecution Services each assume the proposal would not fiscally impact their respective agencies.

For the purpose of this proposed legislation, officials from the **Office of State Public Defender** (**SPD**) cannot assume that existing staff will provide effective representation for any new cases arising where indigent persons are faced with the enhanced penalties for subsequent offenses of failure to provide financial responsibility, escalates to a new Class C Misdemeanor. The definition of Dangerous Felony is expanded to include additional offenses, including DWI where any person not a passenger or two or more people or has a blood alcohol content of at least .18%. A new Class A Misdemeanor is created for those persons charged with viewing photographs, films, etc under the invasion of privacy offenses. The proposed legislation also calls for No SIS or Fines for persons causing the death of any person not a passenger or two or more people or has a blood alcohol content of at least .18% while boating or driving.

While the number of new cases (or cases with increased penalties) may be too few or uncertain to request additional funding for this specific bill, the SPD will continue to request sufficient appropriations to provide effective representation in all cases where the right to counsel attaches.

Oversight assumes the SPD can absorb the additional caseload that may result from this proposal.

Officials from the **Office of the State Courts Administrator** state there may be some impact, but there is no way to quantify that currently. Any significant changes will be reflected in future budget requests.
