FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Insurance, Financial Institutions and Professional Registration (DIFP)** assume that policy amendments may be submitted to the department for review along with a \$50 filing fee. The department expects to see a filing influx of 400. One time additional revenues to the Insurance Dedicated Fund are estimated to be up to \$20,000 (400 \times \$50).

Additional staff and expenses are not being requested with this single proposal, but if multiple proposals pass during the legislative session which require policy form reviews the department will need to request additional staff to handle increase in workload

Officials from the **Department of Health and Senior Services**, the **Department of Social Services** and the **Department of Mental Health** each assume the proposal will have no fiscal impact on their respective organizations.

FISCAL DESCRIPTION

This act specifies that whether an ailment is considered an "emergency medical condition" depends on the person having sufficiently severe symptoms, regardless of what final diagnosis is given.

The act also specifies that health care professionals providing health care services in a hospital within a patient's network shall not bill the patient or the patient's carrier for more than the amount that would be paid to a provider within the patient's network for comparable health care services.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
