#### FISCAL ANALYSIS

#### ASSUMPTION

Officials from the Department of Insurance, Financial Institutions and Professional Registration, the Department of Higher Education, the Office of Prosecution Services, the Department of Public Safety - Missouri Highway Patrol, the Department of Corrections and University of Central Missouri, Missouri Western State University, Missouri State University, State Technical College of Missouri each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Office of the State Courts Administrator** assume there may be some fiscal impact but there no way to quantify that currently. Any significant changes will be reflected in future budget request.

For the purpose of the proposed legislation, and as a result of excessive caseloads, the **Office of the State Public Defender (SPD)** cannot assume existing staff will provide competent, effective representation for any new cases where indigent persons are charged with proposed new crimes relating to the Uniform Agents Athletes Act - several new Misdemeanor offenses. The Missouri State Public Defender System is currently providing legal representation in caseloads in excess of recognized standards.

While the number of new cases may be too few or uncertain to request additional funding for this specific bill, the Office of the State Public Defender will continue to request sufficient appropriations to provide competent and effective representation in all cases where the right to counsel attaches.

**Oversight** assumes the SPD can absorb the additional caseload that may result from this proposal.
