#### FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Economic Development (DED)** - **Business and Community Services, Department of Economic Development - Division of Tourism, Department of Economic Development - Missouri Arts Council** and **Department of Natural Resources** each assume the proposal will have no fiscal impact on their organization.

**Oversight** notes that the agencies mentioned above have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

**Oversight** found a list of Missouri theatres from the League of Historic American Theatres (LHAT). Currently there are three active LHAT members and 45 other theatres that are not members of the LHAT, including: Arrow Rock Lyceum Theatre (Boonville), Fox Theatre (St. Louis) and Up Town Theatre (Kansas City).

Oversight notes the proposal gives DED the option to charge an application fee to cover any costs of the program. Oversight inquired of DED how much would a potential application fee cost for these theaters. **DED** stated the Missouri Arts Council (MAC) notes there are 49 historical Missouri theater buildings; however, very few are producing theatrical performances, even fewer continuously since 1969. MAC estimates fewer than 8 theaters will be eligible. MAC notes they will need to create a process for application and review, build an online form, research the contact information for prospects, design a certificate and print and mail to recipients. MAC would also create a webpage to promote the recipients and the program and design a logo for recipients to use online and in print. MAC does not intend to charge an application fee and expects minimal costs from this proposal; however, MAC can absorb these costs with existing resources.

MAC notes that many, but not all of these theaters are 501(c)3 non-profits.

Officials from the **Joint Committee on Administrative Rules** state that the proposal is not anticipated to cause a fiscal impact to their agency beyond its current appropriation.

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500.

## ASSUMPTION (continued)

The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

**Oversight** assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process.

## FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### FISCAL DESCRIPTION

This bill establishes the designation of "Official State Historical Theater" on theaters that meet specified criteria, including being a 501(c)(3) not-for-profit corporation, performance history, and contribution to tourism and arts promotion. The Missouri Arts Council shall administer the program as specified in the bill and may charge a fee to cover the costs of the program.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
