ASSUMPTION

Officials from the **Office of the Secretary of State** assume the proposal will have no fiscal impact on their organization.

Officials from the **Jackson County Election Board, St. Louis County Board of Elections, and Platte County Board of Elections** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the Office of the Secretary of State, Jackson County Election Board, St. Louis County Board of Elections, and Platte County Board of Elections have stated the proposal would not have a direct fiscal impact on their organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local election authorities and county clerks were requested to respond to this proposed legislation but did not.
