FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education (DESE)** assume the proposal will result in no cost to their organization.

Officials from **Springfield Public Schools** assume this proposal could potentially result in lower quality products resulting in additional repairs or replacement of products, with costs unknown.

Oversight received a limited number of responses from school districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information that we have. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight notes that <u>one</u> school district has stated the proposal could result in unknown costs to the district. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a range of impact from \$0 to an unknown cost.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other school districts were requested to respond to this proposed legislation but did not. FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This act requires that, in any request for proposals by a school district a product to be used may be specified, provided that:

- The RFP does not specify a proprietary product; and
- The RFP does not require action by specified individuals.

The act additionally requires that in accepting proposals, a school district shall accept bids from at least three vendors who supply substantially similar products at substantially similar cost.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
