FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Insurance, Financial Institutions and Professional Registration**, the **State Tax Commission** and the **Office of the State Courts Administrator** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal from this year (HB 770), officials at **Greene County**, the **Monroe County Assessor** and the **Mississippi County Recorder of Deeds** each assumed no fiscal impact to their entity from this proposal.

Oversight notes that the above mentioned agencies each have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other counties and recorder of deeds offices were requested to respond to this proposed legislation but did not.
