FISCAL ANALYSIS

ASSUMPTION

Officials from the Department of Labor and Industrial Relations (DOLIR), Office of Administration, Department of Insurance, Financial Institutions and Professional Registration, Missouri Department of Conservation, and Department of Transportation each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that according to DOLIR the proposal authorizes the Division to pay death benefits and medical expenses approved by an ALJ for injuries occurring prior to January 1, 2014. Oversight notes that the DOLIR has stated the proposal would not have a direct fiscal impact on their organization. The proposal adjusts the priority schedule for payment of liabilities of the Second Injury Fund. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the Jackson County Election Board, St. Louis County Board of Elections, Springfield Public Schools, Kirksville R-III, University of Central Missouri, State Technical College of Missouri, and University of Missouri each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the Office of Administration, Department of Insurance, Financial Institutions and Professional Registration, Missouri Department of Conservation, Department of Transportation, Jackson County Election Board, St. Louis County Board of Elections, Springfield Public Schools, Kirksville R-III, University of Central Missouri, State Technical College of Missouri, and University of Missouri have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other cities, counties, schools, and colleges were requested to respond to this proposed legislation but did not.
