ASSUMPTION

§475.035 - Venue for the appointment of guardian or conservator

Officials at the **Office of the State Courts Administrator**, the **Department of Social Services**, the **Department of Insurance, Financial Institutions and Professional Registration**, the **Office of Prosecution Services** and the **Department of Mental Health** each assume no fiscal impact to their respective agencies from this proposal.

In response to a previous version, officials at the **Office of the Attorney General** assumed no fiscal impact from this proposal.

Oversight notes that the Office of the State Courts Administrator, the Office of the Attorney General, the Department of Social Services, the Department of Insurance, Financial Institutions and Professional Registration, the Office of Prosecution Services and the Department of Mental Health each has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

§475.115 - Death, resignation or removal of a guardian or conservator

Officials at the **Office of the State Courts Administrator**, the **Department of Social Services**, the **Department of Insurance, Financial Institutions and Professional Registration**, the **Office of Prosecution Services** and the **Department of Mental Health** each assume no fiscal impact to their respective agencies from this proposal.

In response to similar legislation from 2018, HCS for HB 1689, officials at the **Office of the Attorney General** assumed no fiscal impact from this proposal.

Senate Amendment #1 - §§209.625 and 472.010 - ABLE Act

In response to similar legislation from this year, SB 426, officials at the **Office of the Attorney General** and the **Department of Economic Development** each assumed no fiscal impact to their respective agencies from this proposal.
