FISCAL ANALYSIS

ASSUMPTION

Officials at the **City of Kansas City** assume passage of this legislation could result in an unknown negative fiscal impact for the City if it costs more to assign municipal court judges, instead of the currently assigned administrative hearing officers, to administrative hearing cases.

Oversight notes in §479.011.1(2), a city or village <u>may</u> establish an administrative system for municipal code violations by ordinance. Oversight assumes if an administrative system is established by the city, it will benefit of the city in its budgetary process. Therefore, Oversight assumes until action is taken by the governing body of the city by ordinance, no direct fiscal impact will be incurred by this proposal.

Officials at the **Department of Revenue** assume, administratively, the proposed legislation will result in an unknown increase in the number of traffic convictions received and processed by the Department. These convictions will be processed manually as the cities and villages do not have an established case management system to send through electronic processes or through the Office of State Court Administrator's (OSCA) electronic process with the Department. A Revenue Processing Tech I (RPT I) can process 340 convictions per day. If the increase is more significant than anticipated, additional FTE will be requested through the appropriations process. The Department anticipates that we will be able to absorb these costs and that there will be No Impact.

Officials at the **Office of the State Courts Administrator** assume no fiscal impact from this proposal.

Oversight notes that the Department of Revenue and the Office of the State Courts Administrator each has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials at the **City of Keytesville** assume little to no fiscal impact from this proposal.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other cities were requested to respond to this proposed legislation but did not.
