Officials from the **Department of Revenue** assume this proposal will result in an increase in mail-in duplicate transactions. The Department anticipates being able to absorb any additional duplicate transaction volume this proposal will result in and therefore assume no fiscal impact. If the increase is substantive, additional FTE will be requested through the appropriations process.

Officials from the **Department of Transportation** and **Department of Public Safety - Missouri Highway Patrol** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the agencies mentioned above have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.
