ASSUMPTION

Officials from the **Department of Economic Development (Division of Energy, Public Service Commission, Office of Public Counsel)**, the **Attorney General's Office**, the **Department of Natural Resources** and the **Metropolitan St. Louis Sewer District** each assume the proposal will have no fiscal impact on their respective organizations.
