#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Department of Public Safety's Office of the Director** and the **Division of Fire Safety** each assume no fiscal impact to their respective agencies from this proposal.

**Oversight** notes that the Department of Public Safety's Office of the Director and the Division of Fire Safety each has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note to these agencies.

In response to similar legislation from 2019, (SB 464), officials at **St. Louis County** and **Greene County** each assumed no fiscal impact to their respective entities from this proposal.

In response to similar legislation from 2018 (HB 1269), officials at **Boone County** assumed no fiscal impact from this proposal.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, other counties were requested to respond to this proposed legislation, but did not. A general listing of political subdivisions included in our database is available upon request.
