#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials at the **Office of the Secretary of State (SOS)** assume each year, a number of joint resolutions that would refer to a vote of the people a constitutional amendment and bills that would refer to a vote of the people the statutory issue in the legislation may be considered by the General Assembly.

Unless a special election is called for the purpose, Joint Resolutions proposing a constitutional amendment are submitted to a vote of the people at the next general election. Article XII section 2(b) of the Missouri Constitution authorizes the governor to order a special election for constitutional amendments referred to the people. If a special election is called to submit a Joint Resolution to a vote of the people, §115.063.2, RSMo, requires the state to pay the costs. The cost of the special election has been estimated to be \$7.8 million based on the cost of the 2016 Presidential Preference Primary.

The SOS is required to pay for publishing in local newspapers the full text of each statewide ballot measure as directed by Article XII, Section 2(b) of the Missouri Constitution and Section 116.230-116.290, RSMo. Funding for this item is adjusted each year depending upon the election cycle. A new decision item is requested in odd numbered fiscal years and the amount requested is dependent upon the estimated number of ballot measures that will be approved by the General Assembly and the initiative petitions certified for the ballot. In FY 2014, the General Assembly changed the appropriation so that it was no longer an estimated appropriation.

In FY19, over \$5.8 million was spent to publish the full text of the measures for the August and November elections. The SOS estimates \$65,000 per page for the costs of publications based on the actual cost incurred for the one referendum that was on the August 2018 ballot.

The SOS will continue to assume, for the purposes of this fiscal note, that it should have the full appropriation authority it needs to meet the publishing requirements. Because these requirements are mandatory, we reserve the right to request funding to meet the cost of our publishing requirements if the Governor and the General Assembly again change the amount or continue to not designate it as an estimated appropriation.

**Oversight** has reflected in this fiscal note, the state potentially reimbursing local political subdivisions the cost of having this joint resolution voted on during a special election in fiscal year 2021. This reflects the decision made by the Joint Committee on Legislative Research, that the cost of the elections should be shown in the fiscal note. The next scheduled statewide primary election is in August 2020 and the next scheduled general election is in November 2020

(FY 2021 for both). It is assumed the subject within this proposal could be on one of these ballots; however, it could also be on a special election called for by the Governor (on a different date). Therefore, Oversight will reflect a potential election cost reimbursement to local political subdivisions in FY 2021.

Officials from the Missouri Senate, Missouri House of Representatives, Office of Administration-Budget and Planning, and Department of Revenue each assume the proposal will have no fiscal impact on their respective organizations.

**Oversight** notes that the Missouri House of Representatives, Missouri Senate, Office of Administration-Budget and Planning, and Department of Revenue each have each stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note for these agencies.

Officials from the **Jackson County Election Board**, **St. Louis County Board of Elections** and **Platte County Board of Elections** each assume the proposal will have no fiscal impact on their organization.

Officials from the **Kansas City Election Board** assume the cost to conduct a single issue election in the Kansas City portion within Jackson County is roughly \$600,000. The state would be required to pay their pro-rata share depending on what other entities participate in that election.

In response to similar legislation SJR 12 from 2019, officials from the **Boone County Clerk's Office** assumed the proposal would impact the County in any instance where a tax is placed on the ballot and receives the required majority of those voting, but the turnout is less than 50% in the district (Boone County). Presumably the issue would not pass, the County would be billed for its share of the election costs and the issue would have to go before the voters again.

**Oversight** notes that any fiscal impact to local governments would still depend on actions by the voters. Oversight assumes the proposal would have no direct impact.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other cities, counties and schools were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.

#### FISCAL DESCRIPTION

This constitutional amendment, if approved by the voters, provides that any proposal by the state or a county, municipality, or other political subdivision for a new tax or fee or an increase in an existing tax or fee that is submitted to the voters for approval shall not become effective unless it receives a qualified majority in favor and at least 50% of qualified voters cast a ballot in the election.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
