FISCAL ANALYSIS

ASSUMPTION

Due to time constraints, **Oversight** was unable to receive some of the agency responses in a timely manner and performed limited analysis. Oversight has presented this fiscal note on the best current information that we have or on prior year information regarding a similar bill. Upon the receipt of agency responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval of the chairperson of the Joint Committee on Legislative Research to publish a new fiscal note.

§10.230 -Korean War Veterans Memorial

In response to similar legislation (SB 656), officials from the **Office of Administration** and the **Department of Public Safety, Missouri Veterans Commission** each assumed the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

§192.2305 - State ombudsman to respond to concerns involving Missouri veterans' homes

In response to the previous version of this proposal, **Oversight** notes the **Department of Health** and **Senior Services** and the **Department of Public Safety**, **Missouri Veterans Commission** each stated the proposal would not have a direct fiscal impact on their respective organizations.
