### FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Missouri Senate** state as written, the resolution does not allow for reimbursement of any kind, so no fiscal impact. However, the Senate finds that Senators will incur travel expenses related to committee meetings and seek reimbursement under the purpose of conducting "other office work" in addition to attending committee meetings. Therefore, the Senate assumes a fiscal impact of \$553 for mileage.

Officials from the **Missouri House of Representatives** assume no fiscal impact. The House will absorb any reasonable costs incurred by members serving on the committee that the joint contingent appropriation does not cover.

**Oversight** assumes the General Assembly is provided with sufficient core funding to handle a certain amount of expense reimbursement each year. Oversight does not consider the amount of expense reimbursement anticipated from passage of this resolution to be of a material amount. Therefore, Oversight will not reflect a fiscal impact from this proposal.
