FISCAL IMPACT – Small Business

FISCAL DESCRIPTION

This act provides that it shall be unlawful for the operator of a motorcycle or motor-tricycle to allow any person under eight years of age to ride as a passenger on a motorcycle or motor-tricycle operated on any highway in this state.

The act shall not apply to the operation of a motorcycle in a parade, caravan, or exhibition which is authorized by law.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
