FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services (DHSS)** state Senate Bill 177 allows nurse practitioners, clinical nurse specialists, and physician's assistants to sign home health service plans. Current Missouri law requires a physician's approval.

Section 197.445 requires the Division of Regulation and Licensure (DRL), Section for Health Standards and Licensure to promulgate rules and regulations regarding home health agencies. The rules and standards adopted shall not be less than the standards established by the federal government for home health agencies under Title XVIII of the Federal Social Security Act.

It is assumed it will take one (1) Regulatory Compliance Managers (average salary \$68,802) approximately 40 hours to make changes to the requirements. Based on 2,080 working hours per year, this would require 0.02 FTE (40 hours / 2,080 hours per year) to assume these duties for a total personal service cost of \$1,376 (\$68,802 x 0.02 x 1).

Reviewing and updating rules are within duties during an inspection for DRL and no extra survey time will be required to conduct the requirements of the proposed legislation. The department anticipates being able to absorb these costs; however, until the FY22 budget is final, the department cannot identify specific funding sources.

Oversight assumes the DHSS has sufficient staff and resources available to absorb the minimal additional duties required by this proposal and will present no fiscal impact for this agency for fiscal note purposes.

Officials from the **Department of Commerce and Insurance** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.
