FISCAL ANALYSIS

ASSUMPTION

Section 386.890 - Net Metering

Officials from the **Department of Commerce and Insurance - Public Service Commission (PSC)** state that this legislation may require a rulemaking by the PSC in order to implement the provisions. Rulemakings generally result in an estimated cost of up to approximately \$4,700.

The PSC is funded by an assessment on Commission-regulated public utilities pursuant to Section 386.370 RSMo, and not by any state general appropriations. Depending on the cumulative effect of all PSC-impacting legislation passed in the current session and the associated increased costs associated with that legislation to the PSC, the PSC may need to request an increase in our appropriation authority and/or FTE allocation as appropriate through the budget process.

Oversight notes that the PSC has stated their agency should be able to absorb the cost associated with this proposal (depending on cumulative effect of all PSC-impacting legislation passed). Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Department of Commerce and Insurance, the Department of Natural Resources, the Missouri Department of Conservation, the Missouri Department of Transportation** and the **Office of Administration** each assume this proposal will have no fiscal impact on their organization.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
