**ASSUMPTION**

Officials the **Office of Administration**, the **Attorney General’s Office**, the **Department of Natural Resources** and the **Missouri Department of Transportation** each assume the proposal would not fiscally impact their respective agencies.

**Oversight** notes this proposal conveys small properties of land from the Department of Natural Resources (DNR) to the Missouri Department of Transportation (MoDOT) for \$1 or less. Oversight assumes the fiscal impacts of this transaction to DNR and MoDOT are not material and therefore we will not reflect a fiscal impact from this conveyance.


