### ASSUMPTION

**Oversight** notes, currently, the Missouri Department of Economic Development receives annual reports from Missouri's Community Improvement Districts in relation to the services provided by the Community Improvement Districts, the revenues collected by the Community Improvement Districts, and expenditures made by the Community Improvement Districts.

This proposed legislation states that the Missouri Department of Economic Development may publish such annual reports on the Missouri Department of Economic Development's website.

Officials from the **Missouri Department of Economic Development** do not anticipate this proposed legislation will cause a fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will not report a fiscal impact for this organization and will reflect a zero (\$0) fiscal impact on the fiscal note.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.


