ASSUMPTION

Officials from the Department of Commerce and Insurance, the Department of Health and Senior Services, the Department of Social Services, the Missouri Department of Conservation, the Missouri Department of Transportation, the Missouri Consolidated Health Care Plan, Kansas City and the City of Springfield each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Department of Public Safety – Missouri Highway Patrol** defer to the Missouri Department of Transportation for the potential fiscal impact of this proposal.
