ASSUMPTION

Officials from the **Office of the State Courts Administrator**, the **Department of Social Services** and the **Department of Health and Senior Services** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight notes according to OSCA's FY 2024 Budget Book, as of January 2020, there are 13 family treatment courts serving 21 counties. These counties include Adair, Knox, Lewis, Jackson, Audrain, Pike, Lincoln, Callaway, Montgomery, Warren, St. Charles, St. Louis, Jefferson, Perry, Bollinger, Cape Girardeau, Scott, Mississippi, Dunklin, Greene and McDonald.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
