# **ASSUMPTION**

Officials from the **Department of Economic Development** and the **Missouri House of Representatives** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal from 2022 (SB 865), officials from the **Missouri Senate** assumed no fiscal impact.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Oversight will assume both the Missouri House of Representatives and the Missouri Senate could absorb the minimal costs of having two additional members each serve on the Missouri Development Finance Board, and will reflect a zero impact on the fiscal note.
