FISCAL ANALYSIS

ASSUMPTION

Officials from **Department of Elementary and Secondary Education (DESE)** state modifications to 163.011.(20), RSMo, will result in approximately the following increase to the Basic Formula payment:

Base Year	Weighting Mo	Weighting Modifier	
2024	0.30	\$	41,384,454.50
2025	0.35	\$	83,386,942.65
2026	0.40	\$	126,251,260.66
2027	0.45	\$	169,807,740.47
2028	0.50	\$	215,540,183.73

For all future years the continued cost is approximately \$215,540,183.73.

Officials from the **Office of Administration (OA) - Information Technology Services Division (ITSD)** assume the new graduated calculation from twenty-five hundredths to fifty hundredths over five years would be best managed through the use of a new maintenance screen. This project will have to be prioritized among other DESE projects if the legislation passes.

OA-ITSD assumes every new IT project/system will be bid out because all ITSD resources are at full capacity. ITSD estimates the project would take 673.92 hours at a contract rate of \$95 for a total cost of \$17,032 with on-going support costs.

Oversight will reflect the costs provided by DESE and ITSD for fiscal note purposes.

FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This act modifies the definition of "weighted average daily attendance" as used in the education funding formula to mean the average daily attendance plus the "weighting modifier for free and reduce price lunch pupils," rather than the product of 0.25 multiplied by the free and reduced price lunch pupil count that exceeds the free and reduced price lunch threshold, plus certain other factors set forth under current law.

This act defines "weighting modifier for free and reduced price lunch pupils" as the product of the free and reduced price lunch pupil count that exceeds the free and reduced price lunch threshold multiplied by 0.30 for fiscal year 2024, by 0.35 for fiscal year 2025, by 0.40 for fiscal year 2026, by 0.45 for fiscal year 2027, and by 0.50 for fiscal years 2028 and each subsequent year.

The same modification is made in the calculation of weighted average daily attendance for special school districts.
