FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Natural Resources (DNR)** notes the following amounts were collected and deposited into the Geologic Resources Fund (0801):

FY 2020:	\$200,585
FY 2021:	\$180,593
FY 2022:	\$185,816

Oversight notes, in response to a similar proposal from 2022 (HCS for SB 984), DNR stated this fund supports two Field Technicians that work on industrial mining activities.

Oversight also notes there was a \$258,400 balance in the Geologic Resources Fund (0801) as of March 31, 2023. Oversight will reflect revenue in the amount of \$188,998 (average of past three fiscal years) continuing due to the fee extension from 2025 to 2031 on the fiscal note.

Officials from the **Missouri Department of Transportation** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for MoDOT.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
