FISCAL ANALYSIS

ASSUMPTION

Officials from the city of **Kansas City** state this legislation would only have a small negative fiscal impact on Kansas City in an indeterminate amount if an annual salary is paid that is greater than the current range limit.

Officials from the **Kansas City Police Department** assume the proposal will have no fiscal impact on their organization.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note. **Oversight** assumes removing the salary range (currently \$80,211 - \$189,726) will allow KCPD more flexibility in hiring/retaining a chief.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
