FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration (OA)** assume the following regarding this proposal:

The Office of Administration, Division of Facilities Management, Design and Construction does not make public appraisal values for property that may be sold or conveyed because public knowledge of such information may hinder the State's ability to gain the best value for the property. Additionally, since the terms of conveyances are yet to be determined, the fiscal impact, if any, cannot be calculated. Therefore, the fiscal impact is \$0 to unknown.

Officials from the **Attorney General's Office** and **Office of the Governor** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight notes this proposal conveys an approximately 7,000 square foot piece of property (0.162 acre) in the City of St. Louis. Oversight assumes the fiscal impacts of this transaction to OA is <u>not material</u> and therefore we will not reflect a fiscal impact from this conveyance.
