FISCAL ANALYSIS

ASSUMPTION

§590.900 – Medical services for veterans and other first responders

Officials from the **Department of Public Safety - Office of the Director (DPS)** state high-level clinician and staff to support the program and ensure FTA rules are being followed would be needed.

Oversight does not have any other information contrary to that provided by DPS and will reflect DPS's estimated fiscal impact to the Electroencephalogram Combined Transcranial Magnetic Stimulation Fund. Oversight assumes the part-time employee would not be provided fringe benefits and the state would only pay Social Security and Medicare benefits of 7.65 percent.

Oversight notes §590.900 establishes a new fund which consists of moneys appropriated by the General Assembly to the fund or any gifts, bequests, or grants. The Department of Public Safety will establish a pilot program to make electroencephalogram (EEG) combined transcranial magnetic stimulation (TMS) available for veterans, first responders, and law enforcement officers, including certain federal agents, with substance use disorder, other mental disorders, or brain injuries. Oversight assumes an unknown income to the Electroencephalogram Combined Transcranial Magnetic Stimulation Fund. For fiscal note purposes, Oversight assumes services provided under this proposal will equal income and net to zero.

Officials from the Department of Health and Senior Services, the Department of Mental Health, the Department of Natural Resources, the Department of Public Safety – (Capitol Police, Fire Safety, Missouri Highway Patrol, and Missouri Veterans Commission), the Department of Social Services, the Missouri Department of Conservation, the Missouri National Guard, the Missouri House of Representatives, the Missouri Senate, the Branson Police Department, the Kansas City Police Department, the St. Louis County Police Department, and the Phelps County Sheriff's Department each assume the proposal will have no fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Rule Promulgation

Officials from the **Joint Committee on Administrative Rules** assume this proposal is not anticipated to cause a fiscal impact beyond its current appropriation.

Officials from the **Office of the Secretary of State (SOS)** note many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for

this fiscal note to the SOS for Administrative Rules is less than \$5,000. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with its core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Officials from the **Office of the State Treasurer** did not respond to **Oversight's** request for fiscal impact for this proposal.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other local law enforcement, fire protection districts, and ambulance and EMS were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

FISCAL IMPACT - Small Business

FISCAL DESCRIPTION

This act provides that the Department of Public Safety shall establish a pilot program to make electroencephalogram (EEG) combined transcranial magnetic stimulation (TMS) available for veterans, first responders, and law enforcement officers, including certain federal agents, with substance use disorder, other mental disorders, or brain injuries.

The Department shall establish locations to provide clinical services and treatments as provided in the act. The Department shall develop rules for the pilot program as provided in the act and shall require any medical provider providing services to submit a report to the General Assembly by December 31st of each year.

This act also establishes the "Electroencephalogram Combined Transcranial Magnetic Stimulation Fund" which shall fund the pilot program. The fund may receive any grants, donations, or appropriations for purposes of operating the pilot program.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
