## **FISCAL ANALYSIS**

#### **ASSUMPTION**

Officials from the **Missouri State Auditor** and the **Department of Commerce and Insurance** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal from 2023 (SB 645), officials from the **Missouri Office of Prosecution Services** also assumed no fiscal impact.

**Oversight** notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

**Oversight** only reflects the responses that we have received from state agencies and political subdivisions; however, counties were requested to respond to this proposed legislation but did not. A general listing of political subdivisions included in our database is available upon request.
