FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Economic Development** and the **Missouri House of Representatives** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal from 2023 (SB 237), officials from the **Office of the Governor** assumed no fiscal impact from the bill.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their respective organizations. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **Missouri Senate (SEN)** state they anticipate a negative fiscal impact to the Senate contingent appropriation to reimburse 2 Senators for travel and per diem to attend meetings of the Missouri Housing Development Commission. In summary, it will cost approximately \$435 per meeting. The SEN assumes no fiscal responsibility for the other committee members.

Oversight assumes adding four members (two from the House of Representatives and two from the Senate) to the Missouri Housing Development Commission would not create a material fiscal impact. Therefore, Oversight will not reflect a fiscal impact from this change.
