Bill Summary: This proposal modifies provisions relating to funding for housing programs.

FISCAL ANALYSIS

<u>ASSUMPTION</u>

Officials from the Department of Health and Senior Services, the Department of Mental Health, the Department of Labor and Industrial Relations, the Department of Public Safety – Director's Office, the Department of Public Safety Highway Patrol, the Department of Public Safety - State Emergency Management Agency, the Department of Social Services each assume the proposal will have no fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for above respective organizations.

Officials from the **Department of Economic Development (DED)** assume the proposal will have no fiscal impact on their organization.

Additionally, **DED**, via e-mail, stated that almost all of similar types of DED programs are funded with federal dollars from HUD, not state. DED does have a few tax credit programs that help organizations that provide assistance, but this legislation appears to be only for direct funded types of programs. Therefore, DED assumes it would need to be a direct general revenue appropriation to a department, as proposed in this bill.

Oversight notes HB 1606 from 2022 was declared unconstitutional as violating the single subject rule of Article III, § 23 of the Missouri Constitution, December 2023, which included Section 67.2300. For purposes of this fiscal note, Oversight will assume Section 67.2300 is being newly implemented.

Additionally, 67.2300 1. (1), notes the term "Department", any department authorized to allocate funds raised by the state or federal funds received by the state for housing or homelessness.

Oversight is uncertain which department(s) will allocate funds or which funds will be allocated. Therefore, Oversight will reflect a potential unknown transfer out from the general revenue, various state funds and federal funds for the purpose of providing funds to local political subdivisions or not-for-profit organizations to assist with housing or homelessness.

Oversight notes Section 67.2300. 4. notes "The department shall provide up to twenty-five percent of the base allocation of such funds as performance payments to political subdivisions or not-for-profit organizations providing such services as rewards for meeting predetermined goals on reductions of:

- (a) Days unhoused;
- (b) Days in jail or prison; and
- (c) Days hospitalized, with the weights of such days to be determined by the department."

Oversight notes the DED, specifically Missouri Housing Development Commission (MHDC), is currently responsible for issuing tax credits for Low Income Housing. The MHDC is also the statutorily designated administrator of the Missouri Housing Trust Fund.

Oversight notes that the Missouri Housing Trust Fund currently maintains a grant program helping the homeless, or the near homeless population in the State. Oversight notes the Trust Fund provided disbursement as follows:

Therefore, **Oversight** will assume that the money designated for the homeless and various services could reach the \$250,000 threshold.

Therefore, **Oversight** will note the transfer of the money from the general revenue, various state funds, and/or federal funds to the local political subdivisions.

Officials from the **City of Kansas City** assume the proposal could have a negative fiscal impact on Kansas City in an indeterminate amount if it subjects Kansas City to increased litigation and thereby the costs of litigation.

Oversight notes the officials from City of Kansas City, in response to the similar proposal SB 791-2024, assumed no fiscal impact on their respective City.

Officials from the **City of Osceola** assume the proposal will have a direct fiscal impact on their organization.

Oversight assumes, for purposes of this fiscal note, that the above cities and other political subdivisions will be able compliant with the rule specified in the proposal. Therefore, Oversight will reflect zero impact for local political subdivisions.

The officials from the Phelps County Sheriff Department, the Saint Louis County Police Department, and the Kansas City Police Department each assume the proposal will have no fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for above respective police departments.

Officials from the **Newton County Health Department** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

FISCAL IMPACT – Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

FISCAL DESCRIPTION

This act amends the section of law which was declared unconstitutional in Byrd, et al. v. State of Missouri, et al.

This act provides that state funds for homelessness shall be used for certain facilities, including parking areas, camping facilities, and short-term shelters, and shall comply with certain requirements as provided in the act. Additionally, any person that owns or operates a private camping facility pursuant to this act shall be immune from liability as provided in the act.

State funds otherwise used for permanent housing projects shall be used to assist individuals with substance use, mental health treatment, and other services like short-term housing. Any state department that is authorized to allocate funds for housing or homelessness shall award certain funds as performance payments for political subdivisions that reduce the number of individuals with days unhoused, days in jail, or days hospitalized.

This act provides that no person shall be permitted to use state-owned lands for unauthorized sleeping, camping, or long-term shelters. Any violation shall be a Class C misdemeanor; however the first offense shall be a warning with no citation.

A political subdivision shall not adopt any policy under which the political subdivision prohibits the enforcement of any ordinance prohibiting public camping, sleeping, or obstruction of sidewalks. The Attorney General shall have the power to bring a civil action to enjoin the political subdivision from failing to enforce provisions of this act.

Any political subdivision with a higher per-capita homelessness rate than the state average according the U.S. Census and Department of Housing and Urban Development data shall

receive no further state funding until the department awarding the funds determines the political subdivision has a lower homelessness rate than the state average or it enforces ordinances prohibiting unauthorized sleeping and camping.

This act shall not apply to shelters for domestic violence victims.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
