**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Department of Commerce and Insurance** assume the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Officials from the **Morgan County Public Water Supply District #2** and **Pulaski County Sewer District #1** each assume the proposal will have a fiscal impact but did not indicate what that impact would be.

**Oversight** cannot determine a direct fiscal impact to these organizations; therefore, Oversight will not reflect a fiscal impact.

Officials from the **Metropolitan St. Louise Sewer District, South River Drainage District, St. Charles County Public Water Supply District #2** and **Wayne County Public Water Supply District #2** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

**Oversight** only reflects the responses received from state agencies and political subdivisions; however, other water and sewer districts were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.


FISCAL DESCRIPTION

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
