FISCAL ANALYSIS

ASSUMPTION

§67.5122 - Uniform Small Wireless Facility Deployment Act

Officials from the **City of Kansas City** assume a negative fiscal impact of an indeterminate amount for this proposal.

Oversight assumes this proposal extends the sunset date to December 31, 2029 and allows the continuation of §§67.5110 to 67.5121 which is intended to encourage and streamline the deployment of small wireless facilities. Oversight will reflect a potential negative unknown fiscal impact to local political subdivisions for this proposal based on the response from the City of Kansas City.

Officials from the **Office of the State Courts Administrator**, the **Department of Commerce and Insurance**, the **Department of Natural Resources** and the **Missouri Department of Transportation** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to similar legislation from this year, HB 1995, officials from the **City of Osceola** assumed the proposal will have no fiscal impact on their organization. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION

This act extends the sunset date of the Uniform Small Wireless Facility Deployment Act from January 1, 2025, to December 31, 2029.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
