§191.960 - Cancer patients' bill of rights

Officials from the **Department of Health and Senior Services**, the **Department of Commerce** and **Insurance**, the **DPS** - **Missouri Veterans Commission**, the **Department of Social Services**, the **Missouri Consolidated Health Care Plan**, the **Missouri Department of Conservation**, the **Missouri Department of Transportation** and the **Oversight Division** each assume the proposal will have no fiscal impact on their respective organizations.

Officials from the **Department of Public Safety (DPS)**, **Missouri Highway Patrol (MHP)** defer to the Missouri Department of Transportation for the potential fiscal impact of this proposal.

Oversight notes DPS/MHP's deferral to MODOT for a statement of fiscal impact; for fiscal note purposes, Oversight assumes no fiscal impact for DPS/MHP.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other nursing homes and hospitals were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.
