**FISCAL ANALYSIS**

**ASSUMPTION**

Officials from the **Joint Committee on Public Employee Retirement (JCPER)** state the bill has no direct fiscal impact to the Joint Committee on Public Employee Retirement. The JCPER’s review of SB 1495 indicates it will not affect retirement plan benefits as defined in Section 105.660(9).

Officials from the **City of St. Louis** and the **Police Retirement System of St. Louis** did not respond to **Oversight’s** request for fiscal impact for this proposal.

**Oversight** does not anticipate a fiscal impact to the retirement system from this proposal. Therefore, Oversight will not show an impact to the employer member, the City of St. Louis.

The proposed legislation appears to have no direct fiscal impact.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
