Officials from the **Department of Social Services**, the **Office of the State Public Defender** and the **Office of the State Courts Administrator** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

In response to similar legislation from the current session (HB 263), officials from the **Missouri Office of Prosecution Services** assumed the proposal would have no fiscal impact on their organization.
