FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Commerce and Insurance** and the **City of Kansas City** each assume the proposal will have no fiscal impact on their respective organizations.

In response to a similar proposal, SB 805 (2024), officials from the **Hancock Street Light District** assumed the proposal would have no fiscal impact on their organization.

In response to a similar proposal from last year SB 568 (2023), officials from the **City of Springfield** assumed the proposal would have no fiscal impact on their organization.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities and counties were requested to respond to this proposed legislation but did not.
