FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Higher Education and Workforce Development (DHEWD)** assume section 173.2865 provides the department with the authority to make grants to eligible entities, as defined by the federal Workforce Innovation and Opportunity Act, or its successor, using funds provided by the act, general revenue, or other funds as appropriated by the general assembly. With that grant authority, the department will be able to issue grants directly rather than going through the procurement process. The estimated cost savings from not having to go through formal procurement would be approximately \$3,488. Time savings for DHEWD staff would be approximately 96 hours.

Oversight does not have any information on the contrary. However, Oversight assumes there would be immaterial savings on the organization. Therefore, Oversight will not reflect the estimated cost savings by DHEWD in the fiscal note.

Oversight notes, the Workforce Innovation and Opportunity Act (WIOA) was signed into law on July 22, 2014. WIOA is designed to help job seekers access employment, education, training, and support services to succeed in the labor market, and to match employers with the skilled workers they need to compete in the global economy. Congress passed the Act with a wide bipartisan majority; it is the first legislative reform of the public workforce system since 1998.

WIOA authorizes Workforce Development Boards (WDBs) to drive the vision for the workforce system at the state and local levels and maintain the critical role of leading state and local implementation of the Workforce Innovation and Opportunity Act (WIOA).

Officials from the **Department of Economic Development, Office of Budget and Planning, Office of Administration** and **Department of Labor and Industrial Relations** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the above mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
