FISCAL ANALYSIS

ASSUMPTION

Officials from the **Missouri Ethics Commission** state the proposal does not have a fiscal impact. If a significant number of entities were to begin reporting such activity as outlined in 130.170 RSMo, additional analysts would be required to assist in providing filing assistance and review of reports filed with the commission. Also, if the Commission identifies significant violations during the process established in Section 105.955.14 (2), (3), RSMo or complaints received increase significantly, an Investigator would be required to provide the proper oversight.

Oversight notes that the above mentioned agency has stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
