ASSUMPTION

§77.150 – Water Projects Constructed by Certain Cities

Officials from the **Department of Natural Resources**, **Kansas City** and the **Wayne County PWSD #2** each assume the proposal will have no fiscal impact on their respective organizations. **Oversight** does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses received from state agencies and political subdivisions; however, other cities and utility districts were requested to respond to this proposed legislation but did not. A listing of political subdivisions included in the Missouri Legislative Information System (MOLIS) database is available upon request.

Oversight received a limited number of responses from cities and utility districts related to the fiscal impact of this proposal. Oversight has presented this fiscal note on the best current information available. Upon receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note.

Oversight assumes this proposal repeals the prohibition on the use of indebtedness or taxes for the construction and operation of such projects. **Oversight** assumes because the potential for increased revenues/costs to local political subdivisions (LPS) regarding this proposal is speculative that the LPS will not incur significant impact related to this proposal. If a fiscal impact were to result, the LPS may request additional funding through the appropriation process.
