ASSUMPTION

§§571.121 and 571.230 – Concealed Carry Permits

Officials from the **Department of Revenue (DOR)** state the Department does not and has not issued conceal and carry permits since 2013. This legislation will have no impact to the Department.

Officials from the **Department of Natural Resources, Department of Public Safety – (Capitol Police and Missouri Highway Patrol), Missouri Department of Conservation, Kansas City Police Department, and St. Louis County Police Department** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other local law enforcement were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
