ASSUMPTION

§304.039 – Motorcycle Operation

Officials from the **Department of Revenue (DOR)** assume the following regarding this proposal:

Administrative Impact

To implement the proposed legislation, the Department will be required to:

- Update Missouri driver guide;
- Update Missouri motorcycle operator manual;
- Update website information; and
- Update interactive applications for automated responses to customers through online system (DORA).

FY 2027 – Driver License Bureau

Research/Data Analyst 40 hrs. @ \$37.14 per hr. = \$1,486

Administrative Manager 40 hrs. @ \$51.40 per hr. = \$2,056

Total = \$3,542

FY 2027 – Strategy and Communications Office

Associate Research/Data Analyst 40 hrs. @ \$31.16 per hr. = \$1,246

Total= \$4,788

The Department anticipates this to be minimal impact and can be absorbed with existing staff.

Oversight assumes DOR is provided with core funding to handle a certain amount of activity each year. Oversight assumes DOR could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, DOR could request funding through the appropriation process.

Oversight notes in §304.039.4, if any operator of a motor vehicle intentionally impedes or attempts to prevent any operator of a motorcycle from operating as permitted by this subsection shall be guilty of an infraction. Oversight assumes there will be a minimum number of infractions; therefore, Oversight will not reflect any fine revenue resulting from infractions.

Officials from the **Missouri Department of Transportation** and **Missouri Highway Patrol** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact in the fiscal note for these agencies.
