FISCAL ANALYSIS

ASSUMPTION

§§108.240, 115.127, 116.250, and 190.050 – Elections

Officials from the **Office of the Secretary of State, Platte County Board of Elections, St. Louis County Board of Elections, Laclede County Clerk, Kansas City, Metropolitan St. Louis Sewer District, South River Drainage District and Wayne County PWSD #2** each assume the proposal will have no fiscal impact on their respective organizations.

Oversight notes that the above-mentioned agencies have stated the proposal would not have a direct fiscal impact on their organization. Oversight does not have any information to the contrary. Therefore, Oversight will reflect a zero impact on the fiscal note.

Officials from the **St. Louis City Board of Elections** state this proposal would have a positive fiscal impact. It would eliminate publication costs, as election notice cards are already mailed six weeks in advance of an election. Publication costs vary per election and size of notice required.

Oversight notes in lieu of publishing notice of an election in a newspaper, election authorities have the option of mailing legal notice to each registered voter within 6 weeks of an election. Oversight assumes there could be a potential savings to local election authorities based on the above response from the St. Louis City Board of Elections but assume the impact would be minimal and will not reflect in the fiscal note.

Oversight only reflects the responses that we have received from state agencies and political subdivisions; however, other cities, school districts, utilities, fire protection districts, and local election authorities were requested to respond to this proposed legislation but did not. Upon the receipt of additional responses, Oversight will review to determine if an updated fiscal note should be prepared and seek the necessary approval to publish a new fiscal note. A general listing of political subdivisions included in our database is available upon request.
