ASSUMPTION

§227.906 – Memorial Highway Naming

Officials from the **Missouri Department of Transportation (MoDOT)** assume the proposal is estimated to have a total negative impact on the State Road Fund of \$4,384. This would be a one-time expense as the language requires MoDOT to fund this designation with no costs for sign fabrication and installation recouped through the participation fee. The estimated cost is \$2,192 per sign, with 2 total signs for this designation.

Oversight does not have any information to the contrary. Therefore, Oversight will reflect the estimated impact by MoDOT in the fiscal note.
